Mutual Legal Assistance Request: Eduard SHIROKOV and Vladimir POPOV

The above request for legal assistance from the Montenegrin authorities was adopted by this unit on 17 January 2017, following a referral to the Home Office's Immigration Enforcement directorate from the International Criminality Unit. The Immigration Enforcement directorate were tasked to answer the request, which asked:

- "Whether SHIROKOV VLADIMOVIC EDUARD, with a travel document – passport number 65 No 4341323, with a date of issuance of 12 August 2016 and valid until 12 August 2021, issued by the competent state authority of the Russian Federation, U*MS 999, born on 20 February 1971 in Cita, a Russian national, has travelled to the United Kingdom, and in

- There are no records held that suggest either Eduard SHIROKOV or Vladimir POPOV have been issued a visa to travel to the United Kingdom, have been encountered by officers at the United Kingdom border or travelled to the United Kingdom in the previous three years.
